Minutes of the Parish Council Meeting held on Thursday the 5th June 2025 at 7:30 pm
in Notton Village Hall.

12/0525-To receive comments or questions from members of the public attending.

13/0525- To consider Apologies and reasons for absence

14/0525-To receive any declarations of personal and/or prejudicial interests appertaining to the agenda.

15/0525-To receive parish information from Ward Councillors/Inform Ward Councillors of Parish issues.

- a. The grass at the Bleakly play area had been cut.
- b. The litter picking on the verges along the A61 was to be started in early June. Cllr. Jaggar noted that the worst stretch was from George Lane heading towards Barnsley.
- c. The District Councillors had attended at the post office and talked to residents. They also walked along Ingsweil Avenue and noted jet washing was required. They also noticed some pavement repairs required in the area 104-114 George Lane. Road markings along Applehaigh lane were of poor quality. All the above had been reported.
- d. Cllr. Taylor asked if it was now normal practice for the details of a planning application to be removed once it had been granted. Cllr. Ali would investigate.
- e. The councillors thanked Cllr. Ali for his work. Cllr Hicks would write to Cllr. Ali to ask if he would prepare an A4 sheet for the minutes and to request he pursues the planning application department.
